Re: Threatening and Abusive Behavior

Dear Mr. Lichtenegger:

I write this letter to confirm that I have been informed by my wife, Ms. Eileen Forte, who was visibly shaken by your clearly threatening and unlawful actions against her today when she served you papers in the case of Forte vs. Lichtenegger, #M70711.

You fortunately did not lay a hand upon Ms. Forte, but you did prevent and obstruct her from leaving your building by sticking your foot in the elevator. You then proceeded to verbally abuse her and threaten her with future arrest, closing with the comment that Ms. Forte was nothing but "trash".

Ms. Forte attempted to look for help but saw no one at the outside reception area of the accounting firm that shares your floor. Were you thinking of dragging Ms. Forte back into your office and assaulting the "trash" as you called her?

I cannot begin to tell you what you have done in causing more stress to both my wife and I realizing that she is in danger now each time she needs to go to your office to present you with papers.

Your true colors hidden just below the surface came out. I am sure you realize that I could obtain a string of secretaries and others that would testify to your erratic and abusive behavior. Many of which I have already commemorated on legally recorded conversations. Ms. Lenora Spencer for one, and Ms. Rosie Caniglia for another can attest to your tendency to emotional uncontrollable outbursts. I have told the police of your showing me several unlicensed guns you keep in your office downstairs at your house, and that I believe that you may have gone off the deep end.

You will also find that your statement to Ms. Forte that she had to serve Mr. Rose, because he is your attorney is wholly incorrect. Look at the attached Proof of Service by Judge Terrance Duncan. Judge Duncan served you and this point was made by me to the court before Judge Duncan on December 17th, 2004 before your co-counsel, Mr. Gerard Rose (the "I'm only along for the ride to help you bilk your insurance carrier" co-counsel).

Ms. Forte intends to file a police report of the matter and has already contacted the Monterey Police Department and is awaiting their call. I intend to make sure it gets investigated properly and documented. If there is justice, you should be called upon to explain yourself and dignify the matter with a response.

You threatened a mother of four that you know you and your colleagues have submitted to cruel and unusual treatment. It is obvious that you will do anything to spite Ms. Forte because you know that it is because of her that our legal documents shine, are on point, and make you look like a putz.

You have really turned the corner straight into hell.
