Re: Request for Citizens Arrest of Monterey County Counsel, Charles McKee

Dear Sheriff Kanalakis:

I write this letter to request that you perform a Citizens Arrest upon the person of Mr. Charles McKee, Monterey County Counsel, *upon my behalf immediately*, for the misprision of a felony and conspiracy to obstruct justice. Even though it is not necessary for me to inform you that this is a *privileged communication*, I feel it is necessary to do so due to your inexcusable conduct in sharing my last *privileged communication* to you with Mr. Charles McKee.

You may refer to my previous letters of November 8<sup>th</sup>, 2005, which you have been provided, for more details of the crime committed by Mr. Charles McKee, in conspiracy with members of the Monterey County District Attorney's Office, DA Dean Flippo, ADA Terry Spitz, Chief Investigator Sue Stryker, ex-Commissioner Richard Rutledge, the Executive Committee of the Monterey Superior Court, and members of the Attorney General's Office, *and witnessed by me*.


Please confirm to me that such arrest has been made within the next 24 hours, and provide me the booking sheet and case number.

If you are not going to effectuate the Citizen's Arrest upon the person of Mr. Charles McKee as I request, please provide a written, detailed explanation of the investigation you conducted, or had conducted, upon which you have determined that Mr. Charles McKee has committed no crime. Please also include all details of the investigation and name of the investigators.

Again, I repeat, that due to your last improper action of sharing my *privileged communication* to you of February 13<sup>th</sup>, 2006, with Mr. Charles McKee, I feel it necessary to *explicitly* request for you not to do so again. It very well could be perceived as a repeated willful decision on your part to aid and abet Mr. McKee, and others, to escape prosecution.

Re: Citizen's Arrest of Mr. Charles McKee/No Response as Usual

Dear Sheriff Kanalakis:

I write this letter to confirm that I did not receive a response from you to my *privileged communication* letters of February 13<sup>th</sup>, 2006, and March 21<sup>st</sup>, 2006, requesting that you facilitate a Citizen's Arrest of Monterey County Counsel, Mr. Charles McKee, on my behalf.

As you know, you also had not responded to my letter of January 20<sup>th</sup>, 2006, and I sent you the letter dated February 13<sup>th</sup>, 2006. In such letter, I attempted to prod you into taking action, or elicit a response, by jokingly and sarcastically stating the following:

"Apparently, you would rather have me handcuff him and throw him into the trunk of my car and bring him to your station.

If I have not heard back from you within the next 72 hours I will take that as an affirmation that is the procedure you would like to have me follow."

Apparently, by your lack of a response, you would rather have me drop you into the same pot of boiling oil other public officials of Monterey County are now immersed in. If I have not heard back from you within the next 24 hours in response to my letter of March 21<sup>st</sup>, 2006, I will accept that as affirmation that is what you would like for me to do.<sup>1</sup> Sound familiar?

The above paragraph is facetious, it's prodding, and it's sarcastic. However, it does not evidence a "clear and convincing threat of criminal violence" against you, just as the letter of February 13<sup>th</sup>, 2006, did not against Mr. McKee. You know, I have children ages 7-15 that all get straight A's and are exceptionally good kids. Your Good ol Boy chums, in trying to save their necks, have attacked my good name, which is also theirs. You have willfully become part of it. How in the world can you look your kids in the face, if you have any, or yourself in the mirror, knowing what you are partaking in? It is all going to come out one day soon!

For the record, I refuse to follow the procedure *you* affirmed you would like to have me follow of handcuffing Mr. McKee, throwing him into the trunk of my car, and bringing him to your station. It is just not my style and *you* all know it.



It very well could be perceived as a repeated willful decision on your part to aid and abet Mr. McKee, and others, to escape prosecution.”


I sincerely regret that you have made the conscious decision to commit a positive act to aid, abet, and conceal public official/judicial corruption in Monterey County. Such willful violation of your duties as the Monterey County Sheriff submits you to criminal prosecution.

I now request that you immediately surrender yourself to the nearest magistrate, or peace officer, according to the provisions of California Penal Code 837 available to me as a citizen to have effectuated by summoning you as a peace officer.

Please confirm to me that this has been done and provide me the booking sheet and docket number within 72 hours OF YOUR RECEIPT OF THIS LETTER.

All previous correspondence sent to you by me was sent to you in your official capacity as the Monterey County Sheriff. A copy of this CERTIFIED LETTER and Notice & Request for your Citizen's Arrest is being filed with the court. A courtesy copy is also being sent to your attorney, Ms. Tracie Kirkbride, advising her of what I believe is a clear conflict of interest that exists from your being represented by her, while she also representing, Monterey County Counsel, Mr. Charles McKee, in DVH 3863, that you have also been issued a subpoena in.
