

PREPARED STATEMENT TO LOCAL MONTEREY MEDIA

RE: JUDGE MICHAEL FIELDS, MONTEREY SUPERIOR COURT BENCH, MS. CRYSTAL POWSER, FORTE VS. JUDGE ROBERT O'FARRELL,

YOU HAVE FALLEN FAR BELOW JOURNALISTIC ETHICS AND STANDARDS IN NOT REPORTING UPON THE ACTIVITIES OF WHAT HAS BEEN LABELED BY LOCAL ATTORNEY MS. LORETTA LOOP AS THE "GOOD OL BOYS".

THE GOOD OLD BOYS ARE COMPRISED OF CORRUPT PUBLIC OFFICIALS, CORRUPT JUDGES , CORRUPT LAW FIRMS OF MONTEREY AND A FEW UNETHICAL PROMINENT CITIZENS WHO UTILIZE THEIR IN FLUENCE FOR FINANCIAL GAIN BY MISUSING AND ABUSING THE LAWS OF OUR COUNTRY.

MEDIA OUTSIDE OF MONTEREY INCLUDING THE LA DAILY JOURNAL HAS BEEN REPORTING ON THE JUDGE FIELDS, JUDGE O'FARRELL, MS. CRYSTAL POWSER SINCE NOVEMBER 17TH, 2005. AS OF THIS DATE, NOVEMBER 23RD, 2005, YOU HAVE NOT REPORTED NOR ATTEMPTED TO MAKE CONTACT WITH MYSELF OR MS. POWSER. YOU WERE PROVIDED THE POWSER DECLARATION ON NOVEMBER 17TH, 2005.

YOUR FILES ARE BRIMMING WITH SUBSTANTIAL INFORMATION PROVIDED YOU BY ME FOR THE PAST 3 YEARS. YOU HAVE BEEN WILLFULLY SILENT AND YOU HAVE ENDANGERED THE LIVES OF MYSELF AND MY FAMILY BY DOING SO.

YOU WILL BE GRANTED NO INTERVIEWS BY ME AND I REQUEST AND DEMAND THAT IF YOU INCLUDE REFERENCE TO ME IN THESE MATTERS THAT THIS STATEMENT BE QUOTED IN IT'S ENTIRETY, OR NOT USED AT ALL.
